**CALL TO ORDER:**

Mayor Pritchard called the meeting to order at 7:05 p.m.

Mark Alianello opened the meeting with an update. The Project description has been submitted to the State Drinking Water Revolving Fund detailing history and the crisis with Blackmar well included and cost estimates for using the springs. NYS DEC will be sending out a mobile treatment plant to use at Blackmar well. The project is being scored now in anticipation of a meeting with Governor Cuomo next week.

Jeff Smith described 3 possible funding sources:

NYS Environmental Facilities Corp., Community Development Block Grant through NYS, USDA Emergency Community Water Program. We will be asking Senators Schumer and Gillibrand for help with USDA along with Congressman Reed.

Mark Alianello distributed photo maps of the water line from the springs showing 4+ breaks in the water line. Plan A would be a \$110,000.00 temporary repair. Plan B is a \$280,000.00 project with new lines from the springs.

Mr. Alianello asked for any documentation of staining or discoloration. The cost of an average water bill was discussed.
