**PUBLIC COMMENT**

1. Code: Many letters went out about property citations. The police sent out notices to a few properties. The new owner of a Lincoln Street property is much easier to reach than the previous, out of state owner.

3. Police: Not much to report on. There was an issue with an out of state driver fleeing when attempting to pull over for speeding on Leavenworth. The issue was discussed.
4. DPW: There will be more money spent on water testing than anticipated. It is a requirement from the county. 3 \$500 water quality tests, and another \$3,000 test. Northrup will be in to fix areas where the grass isn't growing from the water project. No parking signs need to be put up at Chester Jensen's because residents are blocking the driveway making deliveries impossible. A new meter was installed at the second Trading Post location. Additional meters will have to be installed if their plans pan out. No work on the work done at the dump. Leaf pick-up will start in 2 weeks.
5. Clerks: Halloween hours need to be set. Mayor Smith said, because of Covid and the fact that October 31 is a Saturday, perhaps allowing more time would be better. Hours were set for 5pm-8pm. The clerks will release a statement to the public with safety reminders. The siren for the fire department was serviced. The siren was somehow switched off. The webinar referencing the new mandate set by Governor Cuomo was set up. A plan must be submitted by April of next year, after the DPW portion is accepted by the union. Mayor Smith thinks it's ok to open the hall, as long as people wear masks, properly, and maintain social distancing. If people refuse to comply, the clerks are to refuse them service.
