2. Police: Officer Waasdorp definitely needs a new laptop and a new mount for it in the car. There is an issue with someone driving recklessly in the village, he's pretty sure he knows who it is.
3. Treasurer: Nobody has heard anything from East Otto or Otto for the swim program payment. The Annual Report has been filed. ARPA discussion.
4. DPW: They have been bust doing sidewalks. The water breaks interrupted. The summer has been difficult because of all of the rain.
5. Clerks: Smoke detectors need to be installed. The Code Enforcer recommended hard-wired smoke detectors that can communicate with each other.
6. Mayor: The Mayor was told the Dog Warden is retiring in January. The Senior Building on South Street is being sold.
