CALL TO ORDER:

Mayor Smith called the meeting to order at 7:02p.m.

Public Comment

Dr. Huff is here to discuss the crossing guard issue at the school. She has put it out to staff that there is a need for a crossing guard, but there has not yet been anyone interested. She sent out a letter to the village about an agreement between the village and the school regarding payment if a suitable crossing guard is found. DPW Superintendent Wolfe will look into a light and crosswalk if needed. A crossing guard will have a list of expectations to fulfill in order for the village to even consider carrying the position in the future. Nothing concrete was decided.

Thresa is here to discuss the Labor Day Event. Everyone agree that the event is wonderful, and everyone involved did an excellent job. Mayor Smith is concerned that people wrongly assume the village runs the event, and he wants it made clear that the village simply furnishes porta potties.

REPORTS:

1. Code Enforcement: Several complaints were sent in this past month. All have been addressed. He has training next month.
2. Police: Officer Waasdorp is pleased that a problem he has had a difficult time pinpointing in the village has had an official complaint. Now he knows where to go to fix the issue. He asked that anyone who knows this situation is happening, please contact him or the county law enforcement to get it taken care of. He got his new computer and all that was needed to install it.
3. Treasurer: There is a wire form that the Mayor needs to sign. There may be a need to sign documents between this meeting and the October meeting. The board is ok with it. The principle payment for the water project is due in November. ARPA discussion.
4. DPW: They have been busy doing sidewalks and concrete. Acting as the crossing guard while everything is sorted out is difficult because they are very busy.
5. Clerks: The village received numerous complaints this month, mostly about one property. Mr. Watson has sent notices.
6. Trustee Borrowdale: The Class of '89 has purchased the bench and would like to place it as soon as possible. The village would like more information, especially information on who is supposed to maintain said bench.
7. Mayor Smith: Someone needs to reach out to the purchaser of the old Senior Building to find out where they are with the sale. The village just paid another month's worth of bills for the property.
